



LIMITED ONE-YEAR WARRANTY
for
AOC 26"/27"/32"/37"/42" LCD TV Sold Within Australia

AOC warrants this product to be free from defects in material and workmanship for a period of one (1) year after the original date of consumer purchase. During this period, AOC will, at its option, either repair the defective product with new or rebuilt parts, or replace it with a new or rebuilt product at no charge except as *stated below. The defective products that are replaced become the property of AOC.

If you wish to make a claim under warranty, contact AOC authorised service centre, Thomas Electronics. Pack the product along with the dated proof of purchase, and complete the attached form to enable you to process quickly in the event of a claim.

It would assist AOC authorised service centre to ensure that the correct repairs are effected, if you provide a detailed description of the problem you are experiencing at the time of claim.

If you cannot deliver the product in person:

- Pack it in its original shipping container (or equivalent)
- Put the RMA number on the shipping carton
- Pay all shipping charges if out of 100Km radius of the general post office of all cities where onsite service agents are based (please refer to Item 10).

WARRANTY PERIOD

AOC LCD TV covered by One Year Limited on site warranty support as stated on the terms and conditions herein.

WARRANTY CONDITIONS ON AOC MONITORS

1. AOC warrants that the AOC LCD TV you have purchased is free from manufacturing defects in materials and workmanship when dispatched from our warehouse. The receipt of purchase shall be provided as proof of the date of purchase and the warranty period commences as of that date.
2. The onsite coverage is within 100km radius of the general post office of all cities where onsite service agents are based (please refer to Item 10). All other areas will be dealt with on a return to nearest Service Agent via courier at the user's expense or the users can bring the LCD TV to the service agents directly by themselves.
3. This limited warranty does not cover any losses or damages that occur as a result of- *
 - Shipping or improper installation or maintenance
 - Misuse
 - Neglect
 - Any cause other than ordinary commercial or industrial application
 - Adjustment by non-authorized source
 - Repair, modification, or installation of options or parts by anyone other than an AOC Authorised Service Center
 - Improper environment
 - Excessive or inadequate heating or air conditioning or electrical powers failures, surges, or other irregularities
4. In all circumstances, the user must ensure that the LCD TV is packed in appropriate packing. Any damage due to improper packing will be chargeable to the customer.
5. On-site visits made by the on-site service company's personnel will be chargeable at current applicable hourly rates to the customer if: (a) the technician finds the problem is user related; (b) caused by change in normal settings of the LCD TV; or caused by user (software, settings...etc.); (c) determined to be causes not covered by this warranty and/or fallen within the scope as prescribed in item 3.
6. This limited warranty does not cover any of the products that you or any third party have modified or altered; you bear the sole responsibility and liability for any such modification or alteration.

7. The user must ensure that they are available when the on-site service company's representative arrives to pick up (or deliver) the LCD TV. Any additional visits made due to the customer's unavailability will be chargeable to the customer or the customer can bring (or pick up) the monitor to (from) the on-site service company's Agent at their own cost.
8. Defective pixels in LCD panel are not a warranty issue unless they are beyond the criteria prescribed in manufacturer's specifications for pixel defects.
9. This warranty applies to the original purchaser only and is not transferable.
